

# Event Agreement

#### Venue Agreement // Part 1

- Promoter Keeps Ticket Sales
  - Promoter can use preferred Ticket Platform.
- Promoter Provides Staff For Box Office
  - Promoter manages box office staff and guest check in.
  - Reentry is TBD by promoter.
- Venue Provides Security
  - Guests Must be 21+ (UP TO DATE ID / NO SCREENSHOTS)
    - NO EXCEPTIONS
  - Guests and their property will be screened for over-intoxication, weapons, and illegal substances.
  - Guests are not allowed to consume cannabis on or around property.

### Venue Agreement // Part 2

- Tech Sheet
  - Promoter can use in-house gear. Additional gear required for nights performances must be provided by promoter.
  - <u>Review Tech Sheet here</u>
- In House LD (Lighting Designer) and Audio Tech
  - Mandatory Fee to secure date \$250
    - 100% returned if event cancelled before 45 days
- VJ (Video Jockey) is available
  - Can be provided for \$250 deposit payment.
    - 50% returned if event cancelled before 21 days
  - Outsourced VJ arrangements are possible with venue approval
- Event Cut Off / Last Track
  - Stage Manager will determine event cut off time at 1AM.
  - Our license requires Event Cut off at 1:50AM

### Bar Minimums // Part 3

- Sun Thursday
  - **\$1**k
- Friday
  - \$4k
- Saturday
  - ∘ **\$6**k

If minimums are not met, card used for deposit will be charged difference.
